1. MUST BE AN EMPIRE CLUB MEMBER. EMPIRE CLUB MEMBERSHIP IS FREE to all patrons who are 18 years of age or older. NO PURCHASE NECESSARY.

2. Empire City Casino at Yonkers Raceway will host a Porsche Cayenne Giveaway on Mondays, November 13, 20 & 27 at 7PM.

3. Empire Club Members may receive information about the promotion in several ways, including but not limited to their monthly mailer.

4. Empire Club Members may receive entries into the drawings as follows:

- 1 virtual entry for every 100 points earned on a slot machine or electronic table game during the promotional time period.
- Empire Club Members with a partial entry earned as of the drawing dates November 13, 20 & 27, 2017 at 6AM may be provided one entry automatically.

Empire Club Members are responsible for activating their own entries by inserting their Empire Club Card into any functioning slot machine or electronic table games and registering play on each drawing date beginning at 5PM through 6:59PM. All drawings and announcements will be held at or near the Entertainment Lounge located in Gotham Palace or in front of Dan Rooney's Restaurant.

7. Participants must present valid Empire Club card and valid government-issued photo identification. Participants are responsible for any United States Federal, State or local taxes and/or any fees that may be imposed in connection with the acceptance of any gift or prize.

8. PORSCHE CAYENNE GIVEAWAY:

A. On Mondays, November 13, 20 & 27 at 7PM, 10 contestants' names will be randomly selected from all eligible participants via a computer-generated selection process at a designated player tracking workstation terminal to participate in the Porsche Cayenne Giveaway. Once contestants' names are verified, the names will be announced to the audience via a local microphone. In addition, announcements will be broadcast via the public address system on the gaming floor and/or winners' names will be displayed at the drawing location and on the Media Pods located throughout the property if the technology is available.

B. In the event of a mechanical malfunction of the microphone or public address system, such that announcements cannot be made, an attempt will be made to locate the player including checking the player tracking system to see if they can be located on the gaming floor.

C. **Participants must be present to win.** On each drawing date, should a contestant not be immediately present, their name will be announced over the public address system on the gaming floor throughout the course of the next 10 minutes. Each contestant will have 10 minutes from the time their name was first announced to claim their participating spot in the Porsche Cayenne Giveaway. If contestant(s) fails to appear within that allotted time period, he or she will forfeit their chance to participate in the Porsche Cayenne Giveaway and will not receive a prize. If 5 participants are not present after the initial announcements, alternates to equal 10 participants will be called every 10 minutes until a minimum of 5 participants are present. **If a winner/contestant is selected in a drawing and does not claim, they will not be eligible to be called again in the same day. Winner must be present at the time of payout in order to claim prize. At no time will late payouts be authorized. No Exceptions.**

D. On each drawing date, once a minimum of 5 participants have been identified, each contestant, in the order they were drawn, will select an envelope. The number of envelopes available will equal the number of participants.

E. All envelopes will be randomly filled with prize certificates and sealed by an authorized Empire City Casino Internal Audit and/or Income Audit department representative. One envelope will contain a winning Porsche Cayenne Giveaway prize certificate. The remaining envelopes will contain one \$1,000 cash prize certificate.

F. Each contestant will be eligible to win either, one Porsche Cayenne Grand Prize or one \$1,000 cash prize.

H. On each drawing date, the participant that selects the envelope containing the Porsche Cayenne Prize Certificate will receive the Porsche Cayenne OR a \$55,000 cash option prize.

I. **Contestants may win GRAND PRIZE only once over the life of the promotion. The grand prize winner from prior week(s) Porsche Cayenne drawing(s) is NOT eligible to participate in remaining drawings, however any runner up from the prior November Porsche Cayenne drawings are eligible to participate.**

9. **Total winners and prizes:** There may be up to 27 winners of \$1,000 cash and 3 winners of a Porsche Cayenne over the life of this promotion. Dependent on total claims, total prize amount awarded can be as much as \$222,000.
