



## REASONS TO PLAY

1. **MUST BE AN EMPIRE CLUB MEMBER.** EMPIRE CLUB MEMBERSHIP IS FREE to all patrons who are 18 years of age or older. NO PURCHASE NECESSARY.
2. Empire City Casino at Yonkers Raceway will host the 2,018 Reasons to Play promotion on January 4, 11, 18 and 25 from 6pm-9pm each promotional date.
3. On each promotional date in January from 6pm-9pm the first 18 Empire Club Card Members to win a jackpot of \$2,000 or more with their card inserted on valid slot machines will receive an additional \$2,018 Cash once verified by casino officials.
4. There may be as many as 18 promotional winners each date. Max payout per promotional date will be \$36,324.
5. Eligible Empire Club Card Members may only win ONCE per promotional date.
6. Empire Club Members must be playing on a functioning slot machine. Empire Club Card must be inserted and registering play at the time of qualifying jackpot. Electronic table games will not qualify for this promotion.
7. Empire Club Members that are playing on a functioning slot machine with their card inserted at the time of the jackpot will be approached by representatives of Empire City Casino and verified. Players must be present at the machine where the jackpot took place in order to claim their prize. In the event a player is not present at the machine, Empire City will allow 5 minutes for the player to return to claim their prize.
8. Prize will be forfeit if player does not have their Empire Club Card inserted into the machine at the time of the jackpot.
9. Empire Club Members that are playing on a functioning slot machine with their card inserted at the time of their jackpot will be issued their prize in the order of which jackpots are registered in the Empire City Casino systems. All prize winners will be verified and paid out following their jackpot. If for any reason a prize is forfeited, Empire City will continue to award prizes within and up to the first 18 verified winners of jackpots of \$2,000 or more. No prizes will be awarded after the first 18 verified winners each promotional date.
10. Empire Club Members may receive information about the promotion in several ways, including but not limited to their monthly mailer.
11. Participants must present Empire Club card and valid government-issued photo identification on each promotional date in order to participate. Participants are responsible for any United States Federal, State or local taxes and/or any fees that may be imposed in connection with the acceptance of any NY Lottery winning ticket or prize.
12. To process your prize claim, you authorize Empire City Casino to collect personal information about you.

Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the event.
