OFFICIAL RULES 8ight for 8ight Promotion

Mondays in April - June 2018

1. MUST BE AN EMPIRE CLUB MEMBER. EMPIRE CLUB MEMBERSHIP IS FREE to all patrons who are 18 years of age or older. NO PURCHASE NECESSARY.
2. Empire City Casino at Yonkers Raceway will host the 8ight for 8ight Promotion on every Monday in April-June 2018.
3. Empire Club Members may receive information about the promotion in several ways, including but not limited to their monthly mailer.
4. Empire Club Members must earn 8 Empire Points playing any slot machine on the promotional date to receive one \$8 Free Play voucher. Empire Club Members can earn 8 Empire points by inserting their Empire Club Card into any functioning video gaming machine and registering play. Empire Club Members cannot earn points for this promotion on electronic table game machines. Due to a system limitation, if a promotional drawing where CMP is utilized falls on a day which this offer is active electronic table games play may contribute to points earned towards award.
5. Empire Club Members can obtain their earned free play at the main promotions booth from 10AM to 10PM or promotions kiosk from 10AM to 6AM on the promotional date. Free Play is not valid on any electronic table games. After swiping their Empire Club card the Empire Club Member will be prompted to enter their pin number.
6. New Empire Club Members that sign up on the promotional date must obtain their earned free play at a Promotions Booth from 10AM to 10PM.
7. Free Play vouchers will be distributed on a first-come, first-served basis, while supplies last. Limit one Free Play offer per Empire Club Member per promotional date. Free Play is not valid on any electronic table games. Free Play for this promotion EXPIRES the same day it is redeemed.
8. **Participants must be present.** Eligible Empire Club Members must be present to participate.
9. If the guest is redeeming promotional free play at the promotions booth, participants must present valid Empire Club card and government-issued photo identification to participate. Participants are responsible for any United States Federal, State or local taxes and/or any fees that may be imposed in connection with the acceptance of any gift.
10. Falsification of any information will result in ineligibility to claim any gift.
11. No assignment or transfers of prizes allowed.
12. Empire City Casino at Yonkers Raceway may require additional information, notarized statements, or other evidence, as it may deem appropriate, to be supplied by a prize winner.
13. Each participant grants to Empire City Casino at Yonkers Raceway the right to use their name, city of residence, and photograph in order to publicize the event. 14. **Eligibility.** The following persons or categories of persons are not eligible to participate in the promotion or win any prize; any officer or employee of the New York State Gaming Commission, a principal, key employee or employee of any video lottery gaming agent licensed pursuant to this part, except as may be permitted by the Gaming Division for good cause shown, any licensee, registrant, contractor, subcontractor, or consultant, or officer or employee of a contractor, subcontractor, licensee, registrant or consultant, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments, any person subject to a contract with the Division if such contract contains a provision prohibiting such person from purchasing a video lottery gaming ticket or receiving a video lottery gaming prize, any officer or employee of Empire City Casino at Yonkers Raceway, Yonkers Racing Corporation, Brian Boru of Westchester, Inc., Delta Electric, or their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons **residing in the same household as the foregoing persons.** Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the event.
15. Each participant shall indemnify and hold harmless Empire City Casino at Yonkers Raceway and Yonkers Racing Corporation, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this event. Empire City Casino at Yonkers Raceway and Yonkers Racing Corporation assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any gifts or participation in this event.
