## May Getaway Giveaway

### Social Media Drawing

Drawing Dates: May 17 and 31, 2018

- Promotion is offered to all visiting Empire City Casino Instagram OR Facebook who are 18 years of age or older. You do not have to be an Empire Club Member to enter the promotion; however, membership is required to claim prizes.
- Empire City Casino at Yonkers Raceway will host a May Getaway Giveaway Drawing on Thursday May 17 and Thursday May 31, 2018. Guest may enter once per entry period (a.) via Online Entry Form.

- Link to online entry form may be found on Empire City Casino Instagram and Facebook pages over the life of the promotion and may be found through other online mediums.
- Empire Club Members will receive information about this promotion in several ways, including but not limited to their monthly mailer, Empire City Casino social media sites, and traditional advertising methods.
- During each entry period, visitors to Empire City Casino's Instagram OR Facebook will see posts promoting the "May Getaway Giveaway" and a description of the promotion. Visitors will be encouraged via posts to enter the sweepstakes. By following the link to Empire City Casino's submission form, a new page will appear with instructions on how to enter. Fans will be directed to submit a complete entry which includes first & last name, date of birth, email address, Instagram handle and phone number. Participants must be following Empire City Casino on Instagram to qualify to win. Participants must provide valid Instagram handle via Online Entry Form to qualify to win.
- Participants may enter once in each entry period and a total of two times over the life of the promotion. Only one entry will be valid for each drawing date. Participants are responsible for submitting a separate completed entry during each entry period. Entries must be received prior to the applicable drawing date. No entries will be accepted after 5pm on the final day of each entry period.
- On each drawing date at 11AM, one contestant entry will be selected randomly from all eligible participants via a computer-generated process from all eligible entries received.
- On the May 17 drawing date, one winner will be eligible to receive a certificate for Two Nights of Lodging for Two at Mirror Lake Inn Resort & Spa, Lake Placid, NY valued at \$970.

On each drawing date at 12pm each winner will be announced via Empire City Casino's Instagram and Facebook and may be announced on additional social media sites. Winners will have 7 days from drawing date to claim their prize. If winner fails to appear within that allotted time period, the prize will be forfeited. No alternates will be called.
- No assignment or transfers of prizes allowed. Odds of winning depend on number of eligible participants.
- Winners must present Empire Club card and valid government-issued photo identification. In addition, Members must provide proof of their Social Security number by presenting a Social Security Card or by completing a W-9 form or similar document, as necessary to comply with Federal tax reporting requirements. Winners are responsible for any United States Federal, State or local taxes and/or any fees that may be imposed in connection with the acceptance of any prize.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.
- Each entrant and winner shall indemnify and hold harmless Empire City Casino at Yonkers Raceway and Yonkers Racing Corporation, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion.
