

# \$100,000 SLOT TOURNAMENT

# OFFICIAL RULES Three Day \$100k Slot Tournament

Earning Period: June 1-7  
Tournament Dates: June 13, 20, and 27, 2018

1. MUST BE AN EMPIRE CLUB MEMBER. EMPIRE CLUB MEMBERSHIP IS FREE to all patrons who are 18 years of age or older. NO PURCHASE NECESSARY.

2. Empire City Casino at Yonkers Raceway will host a Three Day \$100k Slot Tournament in June 2018.

3. Empire Club Members will receive information about this promotion in several ways including but not limited to the monthly mailer and traditional advertising methods.

4. This tournament will be a 3 day/3 round qualifying event. To qualify for Day1/Round 1 Empire Club Members must earn 1,500 Empire Points between June 1 and June 7 and have a valid email address on file with their Empire Club Account; each qualified Empire club member will receive an invitation to RSVP for the Three Day\$100k Slot Tournament via email. The first 300 participants to RSVP will be eligible for the tournament. Tournament sessions will be filled on a first-come, first-serve basis.

5. Day 1/Round 1: June 13 from 5pm-8:30pm. The first 300 eligible Empire Club Members to RSVP will participate in a tournament of 15 individual sessions comprised of 20 Empire Club Members in each session. On June 13th, the player with the highest score from each individual session will receive a session winner prize of \$500 Cash. (Max: 15 session winners). The 120 players with the highest scores on Day 1/Round 1 will be invited back to compete in Day 2/Round 2 on June 20.

6. Day 2/Round 2: June 20th from 7pm-8:15pm. The players with the highest 120 Score from the June 13th tournament will be eligible to participate in a tournament of 6 individual sessions comprised of 20 Empire Club Members in each session. On June 20th the player with the highest score from each individual session will receive a session winner prize of \$750 Cash. (Max: 6 winners) The 80 players with the highest scores on Day 2/Round 2 will be invited back to compete in Day 3/Round 3 on June 27 (FINALS).

7. Day 3/Round 3: June 27 from 7pm-7:45pm (FINAL DAY) The players with the highest 80 Scores from the June 20th tournament will be eligible to participate in a tournament of 4 individual sessions comprised of 20 Empire Club Members in each session. On June 27th the highest participant score from each individual session will receive a session winner prize of \$1,000 Cash. Additionally, the players with the 10 highest scores on Day 3/Round 3 will be awarded the tournament prizes listed in the \$100k Slot Tournament Prize Structure below (#22).

8. Players with the top scores each day that are invited to return to additional tournament dates will receive notification via email within 24 hours of each tournament date completion.

9. Participants are responsible to appear at the Entertainment Lounge on tournament days to register for their session time. Failing to register before the end of any registration time will result in forfeiture of tournament spot. No registration will be allowed without RSVP. Registration dates and times are as follows:

10. Machine assignments will be selected randomly at registration.

11. Participants are responsible to appear at the tournament location to participate during their scheduled time. Participants will be notified of their session time and machine at registration. Any participant not appearing within the specific time frame will forfeit the session. Make up sessions for registered participants who miss their time slot may be permitted at Marketing discretion.

12. In the event of a mechanical malfunction of the microphone or public address system, such that announcements cannot be made, an attempt will be made to locate the player including checking the player tracking system to see if they can be located on the gaming floor and a phone call if info is on file. Guests are informed of their time slot at registration as such the event may proceed without announcements if needed.

13. Guests may only participate in the Three Day \$100k Slot Tournament ONCE per tournament date and a maximum of three times over the life of the promotion.

14. The tournaments will be played on designated tournament machines only.

15. There will be 20 tournament machines available. Each session may contain as many as 20 participants. Session times each tournament date are as follows:

16. Three (3) minutes of tournament-mode play will be designated for each session. If a player runs out of credits before the 3 minutes has expired, zero will be recorded as their score.

17. If a machine malfunctions the entrant must raise his/her hand for assistance. A Tournament Official will be dispatched to arrange for repair of the machine. If the machine can be repaired, the entrant will then complete the session. If the machine cannot be repaired, the entrant will move to an alternate machine chosen by a Marketing representative. If an incomplete score occurs due to a malfunction, an alternate session may be played and full time awarded for play with the original credits being null and void.

18. In the event of a malfunction during the tournament, entrants may be allowed to complete their session OR be adjointed to a different session space permitting and will still be eligible for a Session Winner prize. In the event an entrant misses their assigned session, they will no longer be eligible for a Session Winner prize.

19. In order to be eligible for a Session Prize, the session must contain at least 10 participants. In the event of a tie, the combined prize money allocated for the corresponding scores will be divided equally among the tied participants.

20. Session Winners will be verified following each individual session. Each Session Winner will be awarded their cash prize immediately following their session at the main cage. Winners must be present to claim prize. Session winners will be allowed to claim their prize immediately following their session and up to the end of the last session. Prize must be claimed within fifteen (15) minutes of the conclusion of the final session for the day or prize will be forfeited. No substitute prizes will be awarded. Cash Method B: Cash payment at cage will be used.

21. TOP 10 PRIZES (FINAL DAY ONLY): After the final session of DAY3/ROUND 3 on June 27th, the participant with the highest score from all sessions of the final tournament date will win 1st place. The Top 10 individual scores from all completed sessions on June 27th will be paid out in order of players with the highest to lowest scores from all sessions on Day 3. In the event of a tie, the combined prize money allocated for the corresponding scores will be divided equally among the tied participants.

22. The Prize Structure for the final winners of the Three Day \$100k Slot Tournament is as follows:

23. The Awards Ceremony for the tournament will be conducted following the end of the last session and will be held in the Entertainment Lounge. Winners must be present to claim prize. Prize must be claimed within fifteen (15) minutes of the prizes being awarded or else prize is forfeited. No substitute prizes will be awarded. Cash Method B: Cash winners will be escorted to the cage for payment.

24. Total winners and prizes: There will be up to 35 winners for the promotion. Total value of the prizes awarded during the course of the promotion will depend on the prize amounts claimed, but may be as much as \$100,000 in cash.

25. No assignment or transfers of prizes allowed. Odds of winning depend on number of eligible participants.

26. Each participant may not win a session prize more than ONCE per promotional date. Each participant may only win one top 10 prize over the life of the promotion.

27. Winners must present Empire Club card and valid government-issued photo identification. In addition, Members must provide proof of their Social Security number by presenting a Social Security Card or by completing a W-9 form or similar document, as necessary to comply with Federal tax reporting requirements. Winners are responsible for any United States Federal, State or local taxes and/or any fees that may be imposed in connection with the acceptance of any prize.

28. A winner payout and release form must be completed by participants and a casino representative prior to awarding any prizes, cash or Free Play. In the event that a qualified winner appears to claim a prize at the promoter's designated time and place and he/she does not have proper identification or all information required to claim; at management's discretion they may be permitted to return by a date & time determined by management with proper identification and any missing information to claim prize. In such instances where the winner is permitted to return outside the promotions designated time to claim, the winner will first be confirmed at the original promotion date & time with any available information including matching the photo in the player tracking account to the person. If there is no photo on file for the customer a still shot will be taken. Upon returning the winner must provide identification which matches the winner's information recorded at the original promotion date & time and the identification will be compared in detail to the customer information and ID on file in the player tracking system. Requirements for witnessing the claiming of the prize by key licensed observes (\$100-\$999) and Internal Audit Manager (\$1000+) or designee based on the value of the prize apply upon returning to claim.

29. To process your prize claim, you authorize Empire City Casino to collect personal information about you.

30. Falsification of any information will result in ineligibility to claim any prize.

31. Empire City Casino at Yonkers Raceway may require additional information, notarized statements, or other evidence, as it may deem appropriate, to be supplied by a prize winner.

32. Each prize winner grants to Empire City Casino at Yonkers Raceway the right to use their name, city of residence, and photograph in order to publicize their winnings. The name and city of residence of prize winners shall be regarded as public information; however, it shall be the policy of Empire City Casino at Yonkers Raceway not to release the street address or telephone number of the prize winners, except as may be required pursuant to lawful authority or urgent necessity. At the discretion of Empire City Casino at Yonkers Raceway, photographs of winners may be taken and used for publicity or to compile a photographic record of winners.

33. Eligibility. The following persons or categories of persons are not eligible to participate in the promotion or win any prize; any officer or employee of the New York State Division of the Lottery, a principal, key employee or employee of any video lottery gaming agent licensed pursuant to this part, except as may be permitted by the Division for good cause shown, any licensee, registrant, contractor, subcontractor, or consultant, or officer or employee of a contractor, subcontractor, licensee, registrant or consultant, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments, any person subject to a contract with the Division if such contract contains a provision prohibiting such person from purchasing a video lottery gaming ticket or receiving a video lottery gaming prize, any officer or employee of Empire City Casino at Yonkers Raceway, Yonkers Racing Corporation, Brian Boru of Westchester, Inc., Delta Electric, or their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.

34. Each entrant and winner shall indemnify and hold harmless Empire City Casino at Yonkers Raceway and Yonkers Racing Corporation, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion. Empire City Casino at Yonkers Raceway and Yonkers Racing Corporation assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any prizes.

35. By participating in the promotion, each participant agrees to and acknowledges that they will abide by the official rules, regulations and procedures of the promotion.

36. Empire City Casino at Yonkers Raceway Marketing officials will resolve any and all disputes concerning any questions that arise in regard to the promotion. In the event of a dispute, New York State law shall govern. The decisions of Empire City Casino at Yonkers Raceway officials will be final.
