OFFICIAL RULES

New York Lottery Powerball® Ticket Giveaway

Earn Up Promotion
Thursdays in June 2018

1. MUST BE AN EMPIRE CLUB MEMBER. EMPIRE CLUB MEMBERSHIP IS FREE to all patrons who are 18 years of age or older. NO PURCHASE NECESSARY.
2. Empire City Casino at Yonkers Raceway will host the New York Lottery Powerball Ticket Giveaway each Thursday in June 2018.
3. Empire Club Members may receive information about the promotion in several ways, including but not limited to their monthly mailer and traditional advertising methods.
4. Each Thursday in June, Empire Club Members must earn 25 Empire Points to redeem one NY Lottery Powerball ticket. Empire Club Members can earn Empire Points by inserting their Empire Club Card into any functioning slot machine or electronic table game and registering play.
5. Empire Club Members that earn 25 Empire Points can claim one NY Lottery Powerball ticket by visiting a Promotions Booth from 10am-10pm each Thursday. Tickets will be distributed on a first-come, first-served basis while supplies last. Limited to 1 earned NY Lottery Powerball ticket per Empire Club Member per promotional date. Limited to the first 2,000 NY Lottery Powerball tickets each promotional date.
6. The approximate value of NY Lottery Powerball Ticket is \$2.
7. Empire Club Members should see the NY Lottery for any details regarding the Powerball game itself. Visit the NY Lottery website at <http://nylottery.ny.gov/wps/portal> for more details.
8. No assignment or transfers of prizes allowed. Odds of winning depend on number of eligible participants.
9. Participants must present Empire Club card and valid government-issued photo identification. In addition, Members must provide proof of their Social Security number by presenting a Social Security Card or by completing a W-9 form or similar document, as necessary to comply with Federal tax reporting requirements. Winners are responsible for any United States Federal, State or local taxes and/or any fees that may be imposed in connection with the acceptance of any prize.
10. Winners of NY Lottery prizes are responsible to redeem their tickets in accordance with all New York Lottery rules and regulations. The Lottery Claim Center and Lottery Retail Window at Empire City Casino at Yonkers Raceway are located on the second floor. Winners are responsible for any United States Federal, State or local taxes and/or any fees that may be imposed in connection with the acceptance of any prize or winning tickets.
11. To process your prize claim, you authorize Empire City Casino to collect personal information about you.
12. Falsification of any information will result in ineligibility to claim any prize.
13. Empire City Casino at Yonkers Raceway may require additional information, notarized statements, or other evidence, as it may deem appropriate, to be supplied by a prize winner.
14. Each participant grants to Empire City Casino at Yonkers Raceway the right to use their name, city of residence, and photograph in order to publicize their winnings. The name and city of residence of prize winners shall be regarded as public information; however, it shall be the policy of Empire City Casino at Yonkers Raceway not to release the street address or telephone number of the prize winners, except as may be required pursuant to lawful authority or urgent necessity. At the discretion of Empire City Casino at Yonkers Raceway, photographs of winners may be taken and used for publicity or to compile a photographic record of winners.
15. Eligibility. The following persons or categories of persons are not eligible to participate in the promotion or win any prize; any officer or employee of the New York State Division of the Lottery, a principal, key employee or employee of any video lottery gaming agent licensed pursuant to this part, except as may be permitted by the Division for good cause shown, any licensee, registrant, contractor, subcontractor, or consultant, or officer or employee of a contractor, subcontractor, licensee, registrant or consultant, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments, any person subject to a contract with the Division if such contract contains a provision prohibiting such person from purchasing a video lottery gaming ticket or receiving a video lottery gaming prize, any officer or employee of Empire City Casino at Yonkers Raceway, Yonkers Racing Corporation, Brian Boru of Westchester, Inc., Delta Electric, or their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons residing in the same household as the foregoing persons. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.
16. Each entrant and winner shall indemnify and hold harmless Empire City Casino at Yonkers Raceway and Yonkers Racing Corporation, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion. Empire City Casino at Yonkers Raceway and Yonkers Racing Corporation assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any prizes.
17. By participating in the promotion, each participant agrees to and acknowledges that they will abide by the official rules, regulations and procedures of the promotion.
