



OFFICIAL RULES

New Member Money Slot Tournament Series

Fridays July 6, 13, 20, and 27, 2018

1. This promotion is offered to all patrons that sign up for an Empire Club Card between the gaming dates of July 1st - July 26th, 2018. MUST BE AN EMPIRE CLUB MEMBER to participate in any tournament date. EMPIRE CLUB MEMBERSHIP IS FREE to all patrons who are 18 years of age or older. NO PURCHASE NECESSARY.

2. Empire City Casino at Yonkers Raceway will host the New Member Money Slot Tournaments on Friday July 6, 13, 20 and 27.

3. Participants may receive information about this promotion in several ways, including but not limited to traditional advertising methods and casino floor signage. Eligible participants with a valid email address on file will receive notification prior to the tournament via email.

4. On each tournament date, the first 200 New Members from the corresponding sign-up period (a.) to register at the Entertainment Lounge Slot Tournament Suite will be eligible to participate in the New Member Money tournament.

5. The first 200 eligible participants to register each tournament date will receive a session time. Session times will occur every 10 minutes between 7:00pm and 9:00pm with time allotted for make-up or malfunction sessions.

6. Registration will end following the 200th participant entered OR the completion of the registration period at 8:00pm each promotional date. Participants are responsible to appear at the Slot Tournament suite in the Entertainment Lounge to register.

7. Machine seating will be assigned randomly prior to the start of each session.

8. Participants are responsible to appear at the tournament location to participate during their scheduled time. Participants will be notified of their session time at registration. Any participant not appearing within the specific time frame will forfeit their session. Make up sessions for registered participants who miss their time slot may be permitted at Marketing discretion.

9. In the event of a mechanical malfunction of the microphone or public address system, such that announcements cannot be made, an attempt will be made to locate the player including checking the player tracking system to see if they can be located on the gaming floor and a phone call if info is on file. Guests are informed of their time slot at registration as such the event may proceed without announcements if needed.

10. Guests may only participate in one tournament date and one completed (non-malfunction) session per player over the life of the promotion.

11. Tournaments will be played on designated tournament machines only.

12. There will be 20 tournament machines available. Each session may contain as many as 20 participants.

13. Two (2) minutes of tournament-mode play will be designated for each session. If a player runs out of credits before the 2 minutes has expired, zero will be recorded as their score.

14. If a machine malfunctions the entrant must raise his/her hand for assistance. A Tournament Official will be dispatched to arrange for repair of the machine. If the machine can be repaired, the entrant will then complete the session. If the machine cannot be repaired, the entrant will move to an alternate machine chosen by a Marketing representative. If an incomplete score occurs due to a malfunction, an alternate session may be played and full time awarded for play with the original credits being null and void.

15. In the event of a malfunction during the tournament, entrants may be allowed to complete their session during the next designated malfunction session OR be adjointed to a different session space permitting and will still be eligible for a Session Winner prize. In the event an entrant misses their assigned session, they will no longer be eligible for a Session Winner prize.

16. Each tournament date, each session winner will receive \$200 Cash. Max of 10 session winners per date.

17. Sessions with less than 10 participants are not eligible for a session prize. In the event of a tie, the combined prize money allocated for the corresponding scores will be divided equally among the tied participants.

18. Session Winners will be verified following each individual session. Each Session Winner will be awarded their cash prize immediately following their session at the main cage. Winners must be present to claim prize. Session winners will be allowed to claim their prize immediately following their session and up to the end of the last session. Prize must be claimed within ten (10) minutes of the conclusion of the final session for the day or prize will be forfeited. No substitute prizes will be awarded. Cash Method B: Cash payment at cage will be used.

19. Following the final session each tournament date, the top 5 individual scores from all completed sessions will be paid out in order of prize structure from highest to lowest score. In the event of a tie, combined prize money allocated for the corresponding scores will be divided equally among tied participants.

20. A minimum of 20 participants must compete in one tournament date in order for Top 5 Prizes to be awarded. In the event that 20 participants do not compete, participants will be eligible to play in any future tournament date.

21. The prize structure for each tournament date is as follows:

Place	Cash Prize
1st Place	\$1,000 Cash
2nd Place	\$400 Cash
3rd Place	\$300 Cash
4th Place	\$200 Cash
5th Place	\$100 Cash

22. Each tournament date, prizes for the top 5 individual scores must be claimed in the Entertainment Lounge following the final session. Winners must be present to claim their prize. Prize must be claimed within (10) minutes of the prizes being awarded or prize will be forfeited. No substitute prizes will be awarded. Cash Method B: Cash winners will be escorted to the cage for payment.

23. Each participant may not win more than ONE total tournament prize and ONE session prize.

24. Total winners and prizes: There may be up to 60 winners over the life of the promotion. Prize amounts awarded are dependent on amounts claimed, but may be as much as \$16,000 Cash over the life of the promotion.

25. No assignment or transfers of prizes allowed. Odds of winning depend on number of eligible participants.

26. Winners must present Empire Club card and valid government-issued photo identification. In addition, Members must provide proof of their Social Security number by presenting a Social Security Card or by completing a W-9 form or similar document, as necessary to comply with Federal tax reporting requirements. Winners are responsible for any United States Federal, State or local taxes and/or any fees that may be imposed in connection with the acceptance of any prize. In the event that a qualified winner appears to claim a prize at the promotion's designated time and place and he/she does not have proper identification or all information required to claim; at management's discretion they may be permitted to return by a date & time determined by management with proper identification and any missing information to claim prize. In such instances where the winner is permitted to return outside the promotions designated time to claim, the winner will first be confirmed at the original promotion date & time with any available information including matching the photo in the player tracking account to the person. *If there is no photo on file for the customer a still shot will be taken. Upon returning the winner must provide identification which matches the winner's information recorded at the original promotion date & time and the identification will be compared in detail to the customer information and ID on file in the player tracking system. Requirements for witnessing the claiming of the prize by key licensed observers (\$100-\$999) and Internal Audit Manager (\$1000+) or designee based on the value of the prize apply upon returning to claim.

27. A winner payout and release form must be completed by participants and a casino representative prior to awarding any prizes, cash or Free Play.

28. To process your prize claim, you authorize Empire City Casino to collect personal information about you.

29. Falsification of any information will result in ineligibility to claim any prize.

30. Empire City Casino at Yonkers Raceway may require additional information, notarized statements, or other evidence, as it may deem appropriate, to be supplied by a prize winner.

31. Each prize winner grants to Empire City Casino at Yonkers Raceway the right to use their name, city of residence, and photograph in order to publicize their winnings. The name and city of residence of prize winners shall be regarded as public information; however, it shall be the policy of Empire City Casino at Yonkers Raceway not to release the street address or telephone number of the prize winners, except as may be required pursuant to lawful authority or urgent necessity. At the discretion of Empire City Casino at Yonkers Raceway, photographs of winners may be taken and used for publicity or to compile a photographic record of winners.

32. Eligibility. The following persons or categories of persons are not eligible to participate in the promotion or win any prize; any officer or employee of the New York State Division of the Lottery, a principal, key employee or employee of any video lottery gaming agent licensed pursuant to this part, except as may be permitted by the Division for good cause shown, any licensee, registrant, contractor, subcontractor, or consultant, or officer or employee of a contractor, subcontractor, licensee, registrant or consultant, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments, any person subject to a contract with the Division if such contract contains a provision prohibiting such person from purchasing a video lottery gaming ticket or receiving a video lottery gaming prize, any officer or employee of Empire City Casino at Yonkers Raceway, Yonkers Racing Corporation, Brian Boru of Westchester, Inc., Delta Electric, or their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.

33. Each entrant and winner shall indemnify and hold harmless Empire City Casino at Yonkers Raceway and Yonkers Racing Corporation, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion. Empire City Casino at Yonkers Raceway and Yonkers Racing Corporation assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any prizes.

34. By participating in the promotion, each participant agrees to and acknowledges that they will abide by the official rules, regulations and procedures of the promotion.

35. Empire City Casino at Yonkers Raceway Marketing officials will resolve any and all disputes concerning any questions that arise in regard to the promotion.
