

DYNASTY ROULETTE BETS

OFFICIAL RULES IGT Dynasty Roulette \$1,000 Bets

Mondays, July, 9, 16, 23, and 30 2018

1. MUST BE AN EMPIRE CLUB MEMBER. EMPIRE CLUB MEMBERSHIP IS FREE to all patrons who are 18 years of age or older. NO PURCHASE NECESSARY.

2. Empire City Casino at Yonkers Raceway will host the IGT Dynasty Roulette \$1,000 Bets promotion Monday, July, 9, 16, 23, and 30 with drawing times at 5pm and 8pm.

3. Empire Club Members will receive information about the promotion in several ways, including but not limited to their monthly mailer and traditional advertising methods.

4. In order to be eligible to win, Empire Club Members must have their Empire Club card inserted and registered into the card reader of a functioning IGT or Spielo brand slot machine or electronic table game at the time of the drawings.

5. Empire Club Members are responsible to ensure his or her Empire Club card is properly inserted and registered in an eligible IGT or Spielo brand slot machine or electronic table game for this promotion.

6. At each drawing time, 1 winner's names will be randomly chosen from all eligible participants via a computer-generated selection process at a designated player tracking terminal.

7. Winners will be announced over the public address system and each contestant will have 10 minutes to appear at the designated promotion area. In addition, announcements will be broadcast via the public address system on the gaming floor and/or winners' names will be displayed at the drawing location and/or the Media Pods located throughout the property if available.

8. If 1 participant is not present after the allotted waiting period, alternates will be called equal to the amount of 1 participant every 10 minutes until 1 participant is present. All drawings and announcements will be held at or near the Entertainment Lounge located in Gotham Palace or in front of Dan Rooney's Restaurant.

9. Each verified winner will be eligible to participate in the IGT Dynasty Roulette \$1,000 Bets Game.

10. IGT Dynasty Roulette \$1,000 Bets Game

a. Each eligible contestant will have one opportunity to play the IGT Dynasty Roulette \$1,000 Bets Game per promotional date.

b. Game setup will be run by Empire City Casino Marketing representatives live on Empire City Casino gaming floor.

c. Once participant selection is complete and participant is verified, contestants will be brought to the designated promotional location adjacent to a live IGT Dynasty Roulette electronic table game.

d. Contestants and representatives will be able to observe the live IGT Dynasty Roulette electronic table game outcomes on the monitor and live wheel of the machine.

e. A physical board with all possible traditional double zero roulette betting options will be set up in the designated area.

f. Once officially prompted by an Empire City Casino Marketing representative, winners will have 30 seconds choose one of any wager on the physical roulette board.

g. The wager will be documented on an official form by Marketing representatives and signed by the player and applicable witnesses.

h. Single wager only may be placed. Multiple bets are not permitted. The value of the wager will be \$1,000.

i. Once the wager is chosen by the contestant and confirmed and documented by the Marketing representative, the outcome of the subsequent spin on the designated live IGT Dynasty Roulette electronic table game will determine the payout of the wager according to official game odds (A.).

j. In the event of a non-winning outcome, promotional contestants will receive \$300 Cash.

11. Odds of winning wagers are subject to live Empire City Casino gaming floor odds. Spin outcomes are random. There are no guaranteed winning outcomes.

12. Empire City Casino is not responsible for any prizes resulting from machine malfunction.

13. Empire Club Members may not win more than ONCE per drawing date.

14. In the event of a mechanical malfunction of the microphone or public address system, such that announcements cannot be made, an employee will be dispatched to the locations where CMP indicates the winners are playing, and they will verbally tell them they have been selected for the promotion and directed to the entertainment lounge to participate. If the player is not located at the machine an attempt will be made to locate him or her including a note on the account, phone call and email if info is on file. No assignment or transfers of prizes allowed. Odds of winning depend on number of eligible participants.

15. Participants must be present to win. Must be present at the time of payout in order to participate in the IGT Dynasty Roulette \$1,000 Bets game.

16. Total winners and prizes: There will be up to 2 winners per promotional date and up to 8 winners over the life of the promotion. Total value of prizes awarded over the course of the promotion will depend on prize amounts claimed, but may be as much as \$72,000 Cash each date and \$288,000 over the life of the promotion.

17. Winners must present Empire Club card and valid government-issued photo identification. In addition, Members must provide proof of their Social Security number by presenting a Social Security Card or by completing a W-9 form or similar document, as necessary to comply with Federal tax reporting requirements. Winners are responsible for any United States Federal, State or local taxes and/or any fees that may be imposed in connection with the acceptance of any prize.

18. A winner payout and release form must be completed by participants and a casino representative prior to awarding any prizes, cash or Free Play.

19. To process your prize claim, you authorize Empire City Casino to collect personal information about you.

20. Falsification of any information will result in ineligibility to claim any prize.

21. Empire City Casino at Yonkers Raceway may require additional information, notarized statements, or other evidence, as it may deem appropriate, to be supplied by a prize winner.

22. Each prize winner grants to Empire City Casino at Yonkers Raceway the right to use their name, city of residence, and photograph in order to publicize their winnings. The name and city of residence of prize winners shall be regarded as public information; however, it shall be the policy of Empire City Casino at Yonkers Raceway not to release the street address or telephone number of the prize winners, except as may be required pursuant to lawful authority or urgent necessity. At the discretion of Empire City Casino at Yonkers Raceway, photographs of winners may be taken and used for publicity or to compile a photographic record of winners.

23. Eligibility. The following persons or categories of persons are not eligible to participate in the promotion or win any prize: any officer or employee of the New York State Division of the Lottery, a principal, key employee or employee of any video lottery gaming agent licensed pursuant to this part, except as may be permitted by the Division for good cause shown, any licensee, registrant, contractor, subcontractor, or consultant, or officer or employee of a contractor, subcontractor, licensee, registrant or consultant, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments, any person subject to a contract with the Division if such contract contains a provision prohibiting such person from purchasing a video lottery gaming ticket or receiving a video lottery gaming prize, any officer or employee of Empire City Casino at Yonkers Raceway, Yonkers Racing Corporation, Brian Boru of Westchester, Inc., Delta Electric, or their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.

24. Each entrant and winner shall indemnify and hold harmless Empire City Casino at Yonkers Raceway and Yonkers Racing Corporation, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion. Empire City Casino at Yonkers Raceway and Yonkers Racing Corporation assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any prizes.

25. By participating in the promotion, each participant agrees to and acknowledges that they will abide by the official rules, regulations and procedures of the promotion.
