



OFFICIAL RULES

New Member Cash Drawing

January 31st, 2019 at 7pm

1. This promotion is offered to all patrons that sign up for an Empire Club Card between January 1st and January 31st at 7pm. **MUST BE AN EMPIRE CLUB MEMBER. EMPIRE CLUB MEMBERSHIP IS FREE** to all patrons who are 18 years of age or older. **NO PURCHASE NECESSARY.**

2. Empire City Casino at Yonkers Raceway will host a New Member Cash Drawing on January 31st, 2019 at 7pm.

3. Participants may receive information about this promotion in several ways, including but not limited to traditional advertising methods and casino floor signage.

4. Participants that sign up for an Empire Club Card between January 1st and January 31st at 7pm will receive one (1) entry into the New Member Cash Drawing for \$10,000 Cash.

5. On January 31st at 7pm, one contestant entry will be selected randomly from all eligible participants via a computer-generated, random number generator process from all eligible entrants. All drawings and announcements will be held at or near the Entertainment Lounge located in Gotham Palace or in front of Dan Rooney's Restaurant.

6. One winner will be selected and eligible to receive \$10,000 Cash.

7. Once winners' names are verified, the names will be announced to the audience via a local microphone. In addition, announcements will be broadcast via the public address system on the gaming floor and/or winners' names will be displayed at the drawing location and on the Media Pods located throughout the property if the technology is available.

8. In the event of a mechanical malfunction of the microphone or public address system, such that announcements cannot be made, an attempt will be made to locate the player including checking the player tracking system to see if they can be located on the gaming floor.

9. Participants must be present to receive the \$10,000 Cash Prize. The winner will be announced via public address system to the casino floor at 7pm on the drawing date. Winner will have 10 minutes from the time of the announcement to claim their prize. If not present at the time of the drawing, \$10,000 cash prize will be forfeit and the winner will be entitled to a \$1,000 Cash prize. If the winner is not present, he or she will be contacted by email or phone after the drawing. Winner will have 5 business days from the drawing date to claim their \$1,000 Cash prize. If the winner fails to appear within the allotted time period, the prize will be forfeited. No alternate winners will be called.

11. Total Winners and Prizes: There may one (1) winner over the life of the promotion. Prize amounts claimed up to \$10,000 Cash.

12. No assignment or transfers of prizes allowed. Odds of winning depend on number of eligible participants.

In addition, Members must provide proof of their Social Security number by presenting a Social Security Card or by completing a W-9 form or similar document, as necessary to comply with Federal tax reporting requirements. 14. A winner payout and release form must be completed by participants and a casino representative prior to awarding any prizes, cash or Free Play.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.

Each entrant and winner shall indemnify and hold harmless Empire City Casino at Yonkers Raceway and Yonkers Racing Corporation, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion.
