



# OFFICIAL RULES

## Stay and Play Slot Tournament

Wednesdays, January 2019

1. MUST BE AN EMPIRE CLUB MEMBER. EMPIRE CLUB MEMBERSHIP IS FREE to all patrons who are 18 years of age or older. NO PURCHASE NECESSARY.
2. Empire City Casino at Yonkers Raceway will host a Stay and Play Slot Tournament each Wednesday in January 2019.
3. Participants may receive information about this promotion in several ways, including but not limited to traditional advertising methods and their monthly mailer. Eligible participants may receive
4. Each promotional date, Empire Club Members that earn 50 Empire Points between 10am and 4pm can redeem a \$10 Free Play from any Promotions Booth or Kiosk. Empire Club Members can earn Empire Points by inserting their Empire Club Card into any functioning video gaming machine and registering play. Empire Club Members cannot earn points for this promotion on electronic table game machines. Due to a system limitation, if a promotional drawing where CMP is utilized falls on a day which this offer is active, electronic table games may contribute to points earned toward awards.
5. Free Play vouchers and discount coupons will be distributed on a first-come, first-served basis, while supplies last. Limit one Free Play offer per Empire Club Member per promotional date. Free Play is not valid on any electronic table games. Free Play for this promotion EXPIRES the same day it is redeemed.
6. Each promotional date, Empire Club Members that earn 50 Empire Points between 10am-4pm will be eligible for a slot tournament from 5pm-7pm.
7. Stay and Play Tournaments are open to the first 200 qualifying Empire Club Members to register in the Entertainment Lounge starting at 4pm each date.
8. Each tournament date, registration will begin at 4pm and end at 6pm. Failing to register for the tournament before 6pm will forfeit tournament entry.
9. Tournament sessions will occur every 10 minutes from 5pm-7pm with time allotted for makeup or malfunction sessions. Guests may only participate in one completed (non-malfunction) tournament session per promotional date.
10. Sessions will be played on designated tournament machines only.
11. There will be 20 tournament machines available for each session. Each session may contain as many as 20 participants.
12. One (1) minute of tournament-mode play will be designated for each hourly tournament. If a player runs out of credits before the 1 minute has expired, zero will be recorded as their score.
13. Machine seating will be assigned randomly prior to each session.
14. If a machine malfunctions the entrant must raise his/her hand for assistance. A Tournament Official will be dispatched to arrange for repair of the machine. If the machine can be repaired, the entrant will then complete the session. If the machine cannot be repaired, the entrant will move to an alternate machine chosen by a Marketing representative. If an incomplete score occurs due to a malfunction, an alternate session may be played and full time awarded for play with the original credits being null and void.
15. Participants are responsible to appear at the tournament location to participate during their scheduled time. Participants will be notified of their session time at registration. Any participant not appearing within the specific time frame will forfeit their session. Make up sessions for registered participants who miss their time slot may be permitted at Marketing discretion.
16. In the event of a mechanical malfunction of the microphone or public address system, such that announcements cannot be made, an attempt will be made to locate the player including checking the player tracking system to see if they can be located on the gaming floor and a phone call if info is on file. Guests are informed of their time slot at registration as such the event may proceed without announcements if needed.
17. Following the final session, the top 20 individual scores from all completed sessions will be awarded prizes in order of prize structure from highest to lowest score. In the event of a tie, combined prize money allocated for the corresponding scores will be divided equally among tied participants.

18. Prizes for each tournament will be issued following the last tournament session. Award announcements will take place in the Entertainment Lounge. Prize must be claimed within (10) minutes of tournament ending or prize will be forfeited. No substitute prizes will be awarded. Cash Method B: Cash winners will be escorted to the cage for payment.
19. Each participant may not win more than once per promotional date.
20. Total winners and prizes. There may be up to 100 winners over the life of the promotion. Prize amounts

- awarded are dependent on amounts claimed but may be as much as \$35,000 Cash.
21. No assignment or transfers of prizes allowed. Odds of winning depend on number of eligible participants.
22. Winners must present Empire Club card and valid government-issued photo identification. In addition, Members must provide proof of their Social Security number by presenting a Social Security Card or by completing a W-9 form or similar document, as necessary to comply with Federal tax reporting requirements. Winners are responsible for any United States Federal, State or local taxes and/or any fees that may be imposed in connection with the acceptance of any prize.
23. A winner payout and release form must be completed by participants and a casino representative prior to awarding any prizes, cash or Free Play.
24. To process your prize claim, you authorize Empire City Casino to collect personal information about you.
25. Falsification of any information will result in ineligibility to claim any prize.
26. Empire City Casino at Yonkers Raceway may require additional information, notarized statements, or other evidence, as it may deem appropriate, to be supplied by a prize winner.
27. Each prize winner grants to Empire City Casino at Yonkers Raceway the right to use their name, city of residence, and photograph in order to publicize their winnings. The name and city of residence of prize winners shall be regarded as public information; however, it shall be the policy of Empire City Casino at Yonkers Raceway not to release the street address or telephone number of the prize winners, except as may be required pursuant to lawful authority or urgent necessity. The following persons or categories of persons are not eligible to participate in the promotion or win any prize: any officer or employee of the New York State Division of the Lottery, a principal, key employee or employee of any video lottery gaming agent licensed pursuant to this part, except as may be permitted by the Division for good cause shown, any licensee, registrant, contractor, subcontractor, or consultant, or officer or employee of a contractor, subcontractor, licensee, registrant or consultant, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments, any person subject to a contract with the Division if such contract contains a provision prohibiting such person from purchasing a video lottery gaming ticket or receiving a video lottery gaming prize, any officer or employee of Empire City Casino at Yonkers Raceway, Yonkers Racing Corporation, Brian Boru of Westchester, Inc., Delta Electric, or their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.
29. Each entrant and winner shall indemnify and hold harmless Empire City Casino at Yonkers Raceway and Yonkers Racing Corporation, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion.
