



# OFFICIAL RULES

## Lucky Couple Social Media Drawing

Thursday, February 28th at 7pm

1. Promotion is offered to all visiting Empire City Casino Instagram OR Facebook who are 18 years of age or older. You do not have to be an Empire Club Member to enter the promotion; however, membership is required to claim prizes.

2. Empire City Casino at Yonkers Raceway will host the Lucky Couple Drawing Thursday, February 28th, 2019 at 7pm.

3. Participants will receive information about this promotion in several ways, including but not limited to, their monthly mailer, Empire City Casino social media sites, and traditional advertising methods.

4. Participants may enter once each date between February 1st and February 28th at 3:59:59pm for a total of 28 entries.

5. During the entry period, visitors to Empire City Casino's Instagram OR Facebook will see posts promoting the "Lucky Couple" Drawing and a description of the promotion. Visitors will be encouraged via posts to enter the sweepstakes. By following the link to Empire City Casino's Online Entry Form, a new page will appear with instructions on how to enter. Fans will be directed to submit a complete entry which includes, first & last name, date of birth, email address, Instagram handle and phone number. Participants must be following Empire City Casino on Instagram to qualify to win. Participants must provide valid Instagram handle via Online Entry Form to qualify to win.

6. Participants may enter 28 times over the life of this promotion between January 1st and 3:59:59pm on February 28th. Participants are responsible for submitting a completed entry each day. No entries will be accepted after the specified period.

7. On the drawing date at 7pm, two (2) contestants will be selected randomly from all eligible participants via computer-generated process from all eligible entries. All drawings and announcements will be held at or near the Entertainment Lounge located in Gotham Palace or in front of Dan Rooney's Restaurant.

9. Once winners' names are verified, the names will be announced to the audience via a local microphone. In addition, announcements will be broadcast via the public address system on the gaming floor and/or winners' names will be displayed at the drawing location and on the Media Pods located throughout the property if the technology is available.

10. In the event of a mechanical malfunction of the microphone or public address system, such that announcements cannot be made, an attempt will be made to locate the player including checking the player tracking system to see if they can be located on the gaming floor.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.
