2. Empire City Casino at Yonkers Raceway will host the IGT Gift Card Giveaways each Friday in April 2019.

3. Participants may receive information about this promotion in several ways, including but not limited to, their monthly mailer and traditional advertising methods.

4. Each promotional date, Empire Club Members may redeem a \$20 Visa Prepaid Card for every 100 Empire Points earned on any IGT/Spielo Slot machine. Empire Club Members can earn Empire Points by inserting their Empire Club Card into any functioning IGT/Spielo slot machine. Empire Club Members cannot earn for this promotion on electronic table game machines. Due to a system limitation, if a promotional drawing where CMP is utilized falls on a day which this offer is active electronic table games play may contribute to points earned towards awards.

5. Empire Club Members may redeem up to four (4) Visa Prepaid Cards per promotional date. Value of cards redeemed may be up to but may not exceed \$80.00 each promotional date.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.
