# OFFICIAL RULES

## Range Rover Riches

### Virtual Drawing

Earning Period: April 1-30, 2019  
Drawing: April 30th, 2019 at 7pm

1. MUST BE AN EMPIRE CLUB MEMBER. EMPIRE CLUB MEMBERSHIP IS FREE to all patrons who are 18 years of age or older. NO PURCHASE NECESSARY.
2. Empire City Casino at Yonkers Raceway will host the Range Rover Riches Drawing on Tuesday, April 30th, 2019 at 7pm.
3. Participants will receive information about this promotion in several ways, including but not limited to their monthly mailer and traditional advertising methods.
4. Empire Club Members will receive 1 virtual entry for every 100 Empire Points earned on any slot machine or electronic table game between April 1st and April 29th. Empire Club Members will receive 1 virtual entry for every 25 Empire Points earned on any slot machine or electronic table game on Tuesday, April 30th from 10am-6:59:59pm. Empire Club Members with a partial entry on the drawing date may be provided one entry automatically.
5. On the drawing date, Empire Club Members are responsible for activating their own entries by inserting their Empire Club Card into any functioning slot machine or electronic table game and registering play between 5:00pm and 6:59:59pm. All drawings and announcements will be held at or near the Entertainment Lounge located in Gotham Palace or in front of The Pub Restaurant.
6. Range Rover Riches Drawing: On April 30th at 7:00pm, 20 contestants' names will be randomly selected from all eligible participants via a computer-generated selection process at a designated player tracking workstation terminal to play in the Range Rover Riches slot tournament. Once winners' names are verified, the names will be displayed at the drawing location and on the Media Pods located throughout the property if the technology is available.
7. In the event of a mechanical malfunction of the microphone or public address system, such that announcements cannot be made, an attempt will be made to locate the player including checking the player tracking system to see if they can be located on the gaming floor.
8. Participants must be present to win. At each drawing time, winners will have 10 minutes to claim their prize. If contestant(s) fails to appear within the allotted time period, he or she will forfeit their chance to participate in the drawing and will not receive a prize. Missing participants will not be drawn in alternate drawings. If 15 participants are not present after the initial announcements, alternates equal to 20 participants will be called every 10 minutes until a minimum of 15 participants are present.
9. Range Rover Riches Slot Tournament: Once a minimum of 15 participants are present, seating will be assigned randomly prior to the start of the session.
  - a. Tournament will be played on designated tournament machines only.
  - b. There will be 20 tournament machines available. The tournament must contain a minimum of 15 participants.

  - d. If a machine malfunctions during the tournament, entrants may be allowed to complete their session immediately following the tournament.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.
