Virtual Drawing Promotion
May-June 2019

1. MUST BE AN EMPIRE CLUB MEMBER. EMPIRE CLUB MEMBERSHIP IS FREE to all patrons who are 18 years of age or older. NO PURCHASE NECESSARY.

2. Empire City Casino at MGM Yonkers, Inc. will host the Race to MGM Vegas \$555,000 Prize Giveaway drawings each Saturday in May and June 2019 from 6pm-10pm each date.

3. Participants may receive information about this promotion in several ways, including but not limited to their monthly mailer and traditional advertising methods.

4. Empire Club Members will receive 1 virtual entry for every 50 Empire Points earned on any slot machine or electronic table game between May 1st and June 29th at 10:29:59pm.

5. On each drawing date, Empire Club Members are responsible for activating their entries by earning one additional entry for 50 Empire Points between 3:00 PM and the drawing time. Activation periods for each drawing time are specified (5a.). All drawings and announcements will be held at or near the Entertainment Lounge located in Gotham Palace or in front of the Pub restaurant.

6. Standard Drawing Days:

a. Standard Drawing Days (Saturday May 4th, 11th, 18th and June 1st, 8th, 15th, 22nd): Each hourly drawing, 25 winners' names will be selected randomly from all eligible participants via a computer-generated selection process at a designated player tracking workstation.

b. Participants may not win more than once per drawing time. In the event of a duplicate winner in a drawing time, an alternate will be drawn until a total of 25 unique winners are drawn.

c. Once winners' names are verified, the names will be announced at the top of each hour via the public address system on the gaming floor. Winners names will be displayed at the drawing location and the Media Pods located throughout the property if the technology is available.

e. In the event of a mechanical malfunction of the microphone or public address system, such that announcements cannot be made, an attempt will be made to locate the player including checking the player tracking system to see if they can be located on the gaming floor.

f. Participants must be present to win. At each drawing time, winners will have 10 minutes to claim their prize. If a winner fails to appear within 10 minutes of the announcement time, no alternate winners will be drawn. The value of any unclaimed prize will be pooled with all other unclaimed prizes for a supplemental drawing to take place each drawing day.

7. Grand Prize Drawing Days:

a. Grand Prize Drawing Days (Saturday May 25th and June 29th): At hourly drawings 6pm, 7pm, 8pm, and 9pm, 25 winners' names will be selected randomly from all eligible participants via a computer-generated selection process at a designated player tracking workstation.

b. Participants may not win more than once per drawing time. In the event of a duplicate winner in a drawing time, an alternate will be drawn until a total of 25 unique winners are drawn.

c. Once winners' names are verified, the names will be announced at the top of each hour via the public address system on the gaming floor. Winners names will be displayed at the drawing location and the Media Pods located throughout the property if the technology is available.

e. Saturday, May 25th at 9:50pm, 10 winners' names will be selected randomly from all eligible participants via a computer-generated selection process at a designated player tracking workstation.

i. Five (5) winners will be selected to receive a luggage set valued at \$550 and \$500 free play.

ii. Four (4) winners will be selected to receive a luggage set valued at \$550, \$500 Free Play, and an MLife Vacation Package valued at \$3,800.

iii. One (1) winner will be selected to receive a luggage set valued at \$550 and a 2019 Infiniti QX50 valued at \$55,000 or a \$30,000 Cash Option. The Grand Prize Winner will have 24 hours from the drawing date and time to claim either the CAR or the Cash Option. If the Grand Prize winner fails to choose within the allotted 24 hours, the Cash Option will be awarded and the CAR will be forfeited.

f. Saturday, June 29th at 9:50pm, 10 winners' names will be selected randomly from all eligible participants via a computer-generated selection process at a designated player tracking workstation.

i. Five (5) winners will be selected to receive a luggage set valued at \$550 and \$500 free play.

ii. Four (4) winners will be selected to receive a luggage set valued at \$550, \$500 Free Play, and an MLife Vacation Package valued at \$3,800.

iii. One (1) winner will be selected to receive a luggage set valued at \$550 and a 2019 Cadillac Escalade valued at \$85,000 or a \$50,000 Cash Option. The Grand Prize Winner will have 24 hours from the drawing date and time to claim either the CAR or the Cash Option. If the Grand Prize winner fails to choose within the allotted 24 hours, the Cash Option will be awarded and the CAR will be forfeited.

g. Participants must be present to win. At each drawing time, winners will have 10 minutes to claim their prize. If a winner fails to appear within 10 minutes of the announcement time, no alternate winners will be drawn. The value of any unclaimed prize will be pooled with all other unclaimed prizes for a supplemental drawing to take place each drawing day. If the CAR is unclaimed in the final drawing time, one winner in the supplemental drawing will be selected to receive the car.

8. Supplemental Drawings:

a. On each drawing date, the sum of unclaimed prize amounts from all drawing times will be pooled for a supplemental drawing.

b. 86 names will be drawn. The sum of the unclaimed prize pool will be divided by \$500 to determine the number of winners selected from this drawing. In the event that unclaimed prizes do not amount to more than \$500, only one winner will be selected for the total amount.

c. Once divided, any outstanding balance of the pool not equal to \$500 will be removed from the prize pool.

d. On Grand Prize Drawing days, if a Grand Prize Car is not claimed in the final drawing hour, the first drawn name in the supplemental drawing will be selected as the winner of the car or cash option.

e. Supplemental Drawings will take place at 10:30pm each date and winners will be announced at 10:45pm. All drawings and

announcements will be held at or near the Entertainment Lounge located in Gotham Palace or in front of the Pub restaurant. f. Once winners' names are verified, the names will be announced at the top of each hour via the public address system on the gaming floor. Winners names will be displayed at the drawing location and the Media Pods located throughout the property if the technology is available.

g. Participants must be present to win. Winners will have 10 minutes to claim their prize. If a \$500 Free Play winner fails to appear within 10 minutes of the announcement time, no alternate winners will be drawn. If a Grand Prize winner fails to appear within 10 minutes of announcement time, one alternate winner will be selected in descending order of drawing until a total of one winner claims the prize.

9. Prize amounts awarded will be determined based on the order in which winners are drawn. Amounts will be awarded in descending order of drawing from highest to lowest.

10. Participants may win a total of six (6) times per drawing date and a total of thirty six (36) times over the life of this promotion.

11. Total winners and prizes: Prize amounts awarded are dependent on prize amounts claimed. There may be up to 1,093 winners of \$400,250 in Free Play, 20 winners of luggage sets with a total value of \$11,000, 8 winners of prize packages with a total value of \$30,400, 2 winners of Grand Prizes valued at \$140,000 or a cash value of \$80,000.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.

Each entrant and winner shall indemnify and hold harmless Empire City Casino at MGM Yonkers, Inc. and Yonkers Racing Corporation, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion.
