



OFFICIAL RULES

\$300,000 Tier Tournament Series

Hot Seat Drawing

August 2nd – October 18th, 2019

1. MUST BE AN EMPIRE CLUB MEMBER. EMPIRE CLUB MEMBERSHIP IS FREE to all patrons who are 18 years of age or older. NO PURCHASE NECESSARY.

2. Empire City Casino at MGM Yonkers Inc. will host \$300,000 Tier Tournament Series every Friday from August 2nd until October 18th, 2019.

3. Participants may receive information about this promotion in several ways including, but not limited to, their monthly mailer and traditional advertising methods.

4. Each promotional date, Empire City Casino will host tournaments for Veteran and Green Members at 6:30pm, 7:30pm, 8:30pm, and 9:30pm and tournaments for Elite and Presidents Members at 7pm, 8pm, 9pm, 10pm.

5. For a chance to participate, Empire Club Members must have their Empire Club Card inserted into any slot machine or electronic table game at the time of the drawing. Qualified members will be determined by status at the time of each drawing.

6. Empire Club Members are responsible to ensure his or her Empire Club Card is properly inserted and registered into an eligible machine at the time of the promotion.

7. At each drawing time, 20 winners' names will be randomly chosen from all eligible participants via computer-generated selection process at a designated player tracking workstation.

8. Contestants names will be announced over the public address system and each contestant will have 10 minutes to appear in the designated promotion area. In addition, announcements will be broadcast via the public address system on the gaming floor and/or winners' names will be displayed at the drawing location and on the Media Pods located throughout the property if the technology is available. If participants are not present after 10 minutes, tournament seat will be forfeited. No alternates will be called.

9. Each verified winner will be eligible to play in a Slot Tournament. Tournament Prize structure varies by Tier type (10a.)

10. All prizes are Free Play. Prize structure is as follow for Tier Tournaments:

11. Guests may participate in each tournament for which they qualify, each hour up to 4 times per promotional date.

12. Tournaments will be played on designated tournament machines only.

13. There will be 20 tournament machines available. Each hourly tournament may contain as many as 20 participants.

14. One (1) minute of tournament-mode play will be designated for each hourly tournament. If a player runs out of credits before the 1 minute has expired, zero will be recorded as their score.

15. If a machine malfunctions during the tournament, entrants may be allowed to complete their session immediately following the hourly tournament. If a contestant does not claim their seat within 10 minutes of their name being called, their tournament seat will be forfeit, no makeup session will be allowed.

16. Participant's placement in each hourly tournament will be paid according to prize structure (10a.). In the event of a tie, combined prize money allocated for the corresponding scores will be divided equally among tied participants.

17. Prizes will be issued following each hourly tournament. Prize must be claimed within (10) minutes of tournament ending or prize will be forfeited. No substitute prizes will be awarded. Cash Method B: Cash winners will be escorted to the cage for payment.

18. Each participant may not win more than ONE hourly tournament prizes per promotional date.

19. No assignment or transfers of prizes allowed. Odds of winning depend on number of eligible participants.

20. Total Winners and Prizes: There may be up to 1,760 winners over the life of this promotion. Prize amounts awarded are dependent on prize amounts claimed but may be as much as \$304,700 in Free Play.

21. Winners must present Empire Club card and valid government-issued photo identification. In addition, Members must provide proof of their Social Security number by presenting a Social Security Card or by completing a W-9 form or similar document, as necessary to comply with Federal tax reporting requirements. The following persons or categories of persons are not eligible to participate in the promotion or win any prize; any officer or employee of the New York State Division of the Lottery, a principal, key employee or employee of any video lottery gaming agent licensed pursuant to this part, except as may be permitted by the Division for good cause shown, any licensee, registrant, contractor, subcontractor, or consultant, or officer or employee of a contractor, subcontractor, licensee, registrant or consultant, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments, any person subject to a contract with the Division if such contract contains a provision prohibiting such person from purchasing a video lottery gaming ticket or receiving a video lottery gaming prize, any officer or employee of Empire City Casino at MGM Yonkers Inc., Brian Boru of Westchester, Inc., Delta Electric, or their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.

28. Each entrant and winner shall indemnify and hold harmless Empire City Casino at MGM Yonkers Inc. and Yonkers Racing Corporation, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion.
