1. MUST BE AN EMPIRE CLUB MEMBER. EMPIRE CLUB MEMBERSHIP IS FREE to all patrons who are 18 years of age or older. NO PURCHASE NECESSARY.

2. Empire City Casino at MGM Yonkers, Inc. will host the Wrangler Winning Weekends drawings each Saturday in August and September 2019 from 6pm-10pm each date.

3. Participants may receive information about this promotion in several ways, including but not limited to their monthly mailer and traditional advertising methods.

4. Empire Club Members will receive 1 virtual entry for every 50 Empire Points earned on any slot machine or electronic table game between August 1st and September 28th at 9:49:59pm.

5. On each drawing date, Empire Club Members are responsible for activating their entries by earning or completing one additional entry for a total of 50 Empire Points between 5pm and the drawing time. Activation periods for each drawing time are specified (5a.). All drawings and announcements will be held at or near the Entertainment Lounge located in Gotham Palace or in front of the Pub restaurant.

6. Each promotional date at each hourly drawing, 20 winners' names will be selected randomly from all eligible participants via a computer-generated selection process at a designated player tracking terminal.

7. Prize Wheel drawings 6pm-9pm:

a. Each promotional date, winners in the 6pm through 9pm drawings will be called to spin the Prize Wheel.

b. Contestants names will be announced over the public address system and each contestant will have 10 minutes to appear in the designated promotion area. In addition, announcements will be broadcast via the public address system on the gaming floor and/or winners' names will be displayed at the drawing location and on the Media Pods located throughout the property if the technology is available. Participants must be present to win. Each contestant will have 10 minutes to claim at the designated promotion area. If a contestant fails to appear within the allotted time period, prize will be forfeited. No alternates will be called.

c. Each winner will be eligible to spin and receive one prize from the Prize Wheel. Any malfunctions or non-full rotation spins on the prize wheel will void the spin, and the contestant will have the opportunity to spin again. This process will continue until a valid spin on the prize wheel has been completed by the contestant. The spin prize amount will be determined by where the peg on the wheel comes to rest.

8. Slot Tournament Drawings:

a. At 10pm each promotional date, winners called will be eligible to participate in a slot tournament.

b. Contestants names will be announced over the public address system and each contestant will have 10 minutes to appear in the designated promotion area. In addition, announcements will be broadcast via the public address system on the gaming floor and/or winners' names will be displayed at the drawing location and on the Media Pods located throughout the property if the technology is available. Winners will have 10 minutes to claim their seat in the slot tournament at the designated location. If 10 participants are not present after the initial announcements, alternates equal to 20 participants will be called one additional time.

c. After the initial drawing, if 10 participants are not present, 20 names will be drawn for alternates. The balance of missing participants will be selected in order of drawing for alternate names.

d. Winners will be able to participate in one completed (non-malfunction) session each promotional date.

e. Tournaments will be played on designated tournament machines only.

f. There will be 20 tournament machines available. Tournaments may contain as many as 20 participants.

g. One (1) minutes of tournament-mode play will be designated for each hourly tournament. If a player runs out of credits before the 1 minute has expired, zero will be recorded as their score.

h. If a machine malfunctions during the tournament, entrants may be allowed to complete their session immediately following the tournament. If a contestant does not claim their seat within 10 minutes of their name being called, their tournament seat will be forfeit, no makeup session will be allowed.

i. The participant with the top individual score will be the Grand Prize winner and be eligible to receive a 2019 Jeep Wrangler or a cash option of \$20,000.

j. Grand Prize winner will have 24 hours to confirm choice of the car or cash option. After 24 hours, prize will defer to cash option.

l. Prizes will be issued following the tournament. Prize must be claimed within 10 minutes of tournament end or prize will be forfeited. No substitute prizes will be awarded. Cash Method B: Cash winners will be escorted to the cage for payment.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.
