1. MUST BE AN M LIFE REWARDS MEMBER. M LIFE REWARDS MEMBERSHIP IS FREE to all patrons who are 21 years of age or older. NO PURCHASE NECESSARY.
2. Empire City Casino at MGM Yonkers Inc. will host \$300,000 Tier Tournament Tournament Series every Friday and Saturday from November 15th – December 28th, 2019.
3. Participants may receive information about this promotion in several ways including, but not limited to, their monthly mailer and traditional advertising methods.
4. Each promotional date, Empire City Casino will host tournaments for M life Rewards Members every 30 minutes from 6:30pm-10:00pm.
5. In order to qualify, M life Rewards Members must have registered play on any machine within 30 minutes of any drawing time.
6. M life Rewards Members are responsible to ensure his or her M life Rewards Card is properly inserted and registered into an eligible machine at the time of the promotion.
7. Drawings for Sapphire, Pearl and Gold tiers will take place each hour at 6:30pm, 7:30pm, 8:30pm, and 9:30pm. Drawings for Platinum and Noir tiers will take place at 7:00pm, 8:00pm, 9:00pm, and 10:00pm.
8. At each drawing time, 20 winners' names will be randomly chosen from all eligible participants via computer –generated selection process at a designated player tracking workstation.
9. Contestants names will be announced over the public address system and each contestant will have 10 minutes to appear in the designated promotion area. In addition, announcements will be broadcast via the public address system on the gaming floor and/or winners' names will be displayed at the drawing location and on the Media Pods located throughout the property if the technology is available. If participants are not present after 10 minutes, tournament seat will be forfeited. No alternates will be called.
10. Each verified winner will be eligible to play in a Slot Tournament. Tournament Prize structure varies by Tier set.
11. Freeplay prize structure for each Tier Tournament is as follows. Freeplay prizes are not valid on electronic table games.

12. Guests may participate in each tournament for which they qualify, each half hour up to 4 times per promotional date.
13. Tournaments will be played on designated tournament machines only.
14. There will be 20 tournament machines available. Each tournament may contain as many as 20 participants.
15. One (1) minute of tournament-mode play will be designated for each hourly tournament. If a player runs out of credits before the 1 minute has expired, zero will be recorded as their score.
16. If a machine malfunctions during the tournament, entrants may be allowed to complete their session immediately following the hourly tournament. If a contestant does not claim their seat within 10 minutes of their name being called, their tournament seat will be forfeit, no makeup session will be allowed.
17. Participant's placement in each tournament will be paid according to prize structure (11a.). In the event of a tie, combined prize money allocated for the corresponding scores will be divided equally among tied participants.
18. Prizes will be issued following each tournament. Prize must be claimed within (10) minutes of tournament ending or prize will be forfeited. No substitute prizes will be awarded. Cash Method B: Cash winners will be escorted to the cage for payment.
19. Each participant may not win more than one tournament prize per half hour drawing and no more than 4 tournament prizes each promotional date.
20. No assignment or transfers of prizes allowed. Odds of winning depend on number of eligible participants.
21. Total Winners and Prizes: Prize amounts awarded are dependent on prize amounts claimed. There may be as many as 1,345 winners of \$317,810 in FREEPLAY.

22. Winners must present M life Rewards Card and valid government-issued photo identification. In addition, Members must provide proof of their Social Security number by presenting a Social Security Card or by completing a W-9 form or similar document, as necessary to comply with Federal tax reporting requirements. Winners are responsible for any United States Federal, State or local taxes and/or any fees that may be imposed in connection with the acceptance of any prize.
23. A winner payout and release form must be completed by participants and a casino representative prior to awarding any cash or merchandise prizes.
24. To process your prize claim, you authorize Empire City Casino to collect personal information about you.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.
