1. MUST BE AN M life® REWARDS MEMBER. M life® REWARDS MEMBERSHIP IS FREE to all patrons who are 21 years of age or older. NO PURCHASE NECESSARY.

2. Empire City Casino at MGM Yonkers will host the \$700,000 Grand Prize Pyramid each Saturday in March and April. Drawings will take place from 6pm-10pm each evening.

3. Participants may receive information about this promotion in several ways including, but not limited to, their monthly mailer and traditional advertising methods.

4. During the entry period from March 1st – April 25th at 9:59:59 PM, M life® Rewards Members will receive one complimentary entry for any registered carded rating. Members will receive one (1) additional entry for every 50 Points earned on any slot machine or electronic table games. Bonus Entries Days: Members will receive five (5) additional entries for every 50 points earned on Thursdays during the entry period.

5. Members are responsible for activating their entries by registering any carded rating within two hours of the drawing time on the drawing date.

6. Winning names will be drawn 15 minutes prior to each hourly announcement to allow for proper verification.

7. At each hourly drawing, 20 winners' names will be randomly selected from all eligible participants via computer-generated selection process at a designated player tracking station.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.
